We may receive information from:

- * Analytics providers
- * Advertising networks
- * Payment processors

3. Legal Bases for Processing (GDPR Article 6)

We process your personal data under the following lawful bases:

Consent: For marketing emails, cookie tracking, and any optional features.

Contract Performance: To provide services, process transactions, and manage your account.

Legitimate Interests: To improve the Site, ensure security, and operate our business.

Legal Obligations: For tax, accounting, fraud prevention, and regulatory compliance.

4. How We Use Your Data

We process your data for purposes including:

- * Operating and maintaining the Site
- * Personalizing your experience
- * Processing orders, billing, and account management
- * Sending service updates or marketing communications (only with consent)
- * Website analytics and performance monitoring
- * Security and fraud prevention
- * Responding to your inquiries

Where required to comply with law, court orders, or enforcement requests.

In the event of a merger, acquisition, or asset sale.

7. International Data Transfers

Your data may be processed outside your country. When transferring data outside the European Economic Area (EEA), we rely on:

- * ****Standard Contractual Clauses (SCCs)****

- * **Adequacy decisions**
- * Other lawful safeguards as required by GDPR

8. Data Retention

We retain personal data only as long as necessary for:

- * Resolving disputes
- * Business continuity

Where possible, we specify retention periods directly. If not, we use criteria based on necessity.

- Right to Erasure - Request deletion of your data
- Right to Restrict Processing - Limit how your data is used
- Right to Data Portability - Receive your data in a portable format
- Right to Object- Object to processing based on legitimate interests or direct marketing
- Right to Withdraw Consent - At any time for consent-based processing
- Right Not to Be Subject to Automated Decision-Making
